



The East Falls Church Planning Study: History and Status

For many years, Arlington County has been known for its foresight in the way that it developed its portion of the Metrorail system, especially the segment from Rosslyn to Ballston. Arlington chose to pursue walkable, mixed-use development at relatively high densities around the stations, with the development density tapering off as one got farther from the stations. Beyond the areas immediately surrounding the Metrorail system, one typically found low- to medium-density residential areas. Because of the way the redevelopment was done (i.e., walkable, mixed-use development around rail stations), Arlington was able to increase development levels with little or no increase in vehicular traffic. The approach chosen by Arlington, also known as "transit oriented development," or TOD, was not always the approach used by other jurisdictions, such as Fairfax County.



For each station where new development was planned, Arlington County typically developed a "sector plan," which served as a guide to future development. The East Falls Church (EFC) station, which lies outside the Rosslyn-Ballston corridor, never had a sector plan, in part because Arlington's General Land Use Plan (GLUP) envisioned that the EFC area would remain a low-density suburban area with some industrial land uses. For the last several years, the Arlington East Falls Church Civic Association (AEFCCA), the civic association that contains the EFC Metro Station, has been pushing to have a sector plan or a "mini sector plan" developed for the area around EFC, with the idea that the AEFCCA citizens wanted to develop a vision for the EFC area before it was redeveloped by developers using what would be allowed "by right."

When it was clear that a planning study would be conducted, I and others in the WCA sought to have a seat at the table. In September 2007, a planning study was begun, known as the EFC Planning Study. Its purpose was to generate a land use and transportation vision for transit-oriented development in the EFC area of Arlington County and the City of Falls Church. The goal of the visioning exercise is to develop a concept plan that will set height, density, use mix, and urban design standards for Arlington County sites, such as the EFC Metrorail park-and-ride, kiss-and-ride lot, and other sites that are likely to redevelop in the study area. The City of Falls Church has its own plan, the 2005 Comprehensive Plan. The process could result in changes to the GLUP and/or zoning.

A citizen task force, known as the EFC Planning Study Task Force, was established to guide the study. The task force has 19 members, 15 of whom are appointed by the Arlington County Board. Three Arlington civic associations are represented on the task force: AEFCCA WCA, and Madison Manor. There also is representation from the Virginia Department of Transportation (VDOT), WMATA, and the City of Falls Church. The EFC station is owned by WMATA, and VDOT owns more than half of the park-and-ride lot, which lies within its right-of-way.

The study was to have taken about 18 months, but it has now been going on for about two years. This is not the only study or planning effort of this type that has gone on in the EFC area. Others include:

- East Falls Church Land Use Study (1986)
- Arlington-Falls Church Ad-Hoc Planning Committee: Final Report (1987)
- WMATA East Falls Church Station Access Study (2002)
- Virginia Tech Study, East Falls Church Metro Area Plan (2004)
- Arlington East Falls Church Civic Association Metro Survey (2005)

A number of potential future development proposals have been presented to the task force, both for land use and transportation.

The task force generally meets about once a month. Unfortunately, the progress of the study has been delayed recently, due to both the cancellation of several task force meetings and the economic recession, which is straining the county's ability to carry out all of its mandates with its limited staff. The July and October meetings were cancelled due to an electrical problem in the building where the meetings had been held. A subsequent make-up meeting was also cancelled, again due to electrical problems. A meeting was held on October 28. A summary of that meeting was sent to the WCA e-mail distribution list on November 1. Unfortunately, Arlington County staff had to cancel both the November and December meetings of the task force, presumably because a preliminary plan was not yet ready to share with the task force.

The next scheduled meeting of the task force is Wednesday, Jan. 27. In advance of that meeting, Arlington County staff is expected to forward to the task force a draft of the EFC Area Plan. At the January meeting, Arlington County staff will provide a review of the document and will accept questions and comments; however, no formal task force action will be taken on the draft plan. A subsequent task force meeting, as well as broader community forums/meetings, will be scheduled thereafter for further public input on the proposed plan.

Help Create Arlington's Transit Development Plan

Arlington Transit (ART) with the assistance of the Virginia Department of Rail and Public Transportation (DRPT) has initiated a study that will result in a Transit Development Plan (TDP), which ultimately will be adopted by the County Board. The community is invited to join ART and DRPT staff and the TDP consultant team for an initial briefing and work session, which will be held on January 28, 2010 from 7:00 pm to 9:00 pm at the Navy League Building - main floor conference room, 2800 Wilson Blvd.

The Transit Development Plan will be a comprehensive six-year plan that will guide the growth of transit and paratransit services provided by the County through ART and STAR and by the Washington Metropolitan Area Transit Authority (WMATA) through Metrorail, Metrobus and MetroAccess. The TDP will build upon the policies, goals and objectives adopted by the County Board in the Master Transportation Plan and in the Transit Element.

ART is now in the initial stage of the TDP study, collecting data and analyzing existing and programmed services. At this initial meeting the consultant team will provide an overview of existing services and program plans, setting the stage for Arlingtonians to discuss with other stakeholders, staff and consultants, their interests for the future of the County's transit and paratransit services.

Leaf Collection Program Extended Until January 29

Arlington County has extended its leaf collection program until January 29 in order to take a second pass through each civic association.

The Williamsburg Civic Association is in Zone 5 – the last on the schedule. A definitive date for collections cannot be provided, as some areas have heavier leaf piles than others, and the heavy leaf areas and cold weather play a factor in how quickly the work can get done. The County says it will work as quickly as possible to vacuum the leaves, while also continuing with its core services and other seasonal programs.

To recycle your leaves, place leaves in biodegradable bags only. Do not use plastic bags! Leaf bags will be collected on the next business day after your regular trash collection day

Census Workers Wanted

Every 10 years, a census of our population is conducted. The results help determine how federal funds are spent in our community on things like roads, parks and other public services, as well as our representation in government.

The U.S. Department of Commerce seeks assistance with conducting the Census in 2010; in Arlington, the government needs Arlington residents to be "enumerators," or census takers.

A 2010 Census job offers a good pay, flexible hours, paid training, and the chance to work independently in your own community. Work can last a few days or a few weeks, or more.

People are hired for census work based on veterans' status and on scores on a test administered by the Census. The test is a short, multiple choice test that tests math, clerical skills, map reading, reading skills and evaluating alternatives.
